

I also certify that 6 ballot papers were declined or taken from the voting station.

\*As noted in The results of the election report, an error was found when reconciling the ballots issued for the advanced poll. It was found that 230 ballots were issued for the mayoralty position and 229 ballots issued for the council positions. The voting book showed 229 voters in attendance at the poll. The only explanation was that the heat of the polling station caused perspiration and the sticking of two ballots. The one ballot error does not affect the results of the mayoralty race significantly with either the result being: Gamble582/Licharson194 or Gamble583/Licharson193.
